MINUTES

Board of Directors/Member Meeting Sunday, January 17, 2021 at 4:00 pm By ZOOM

Present: Officers: Steve Smith, Sam Hudspath, and Cindy Foster. Directors: Bonnie Farrar, Jeannette Parker, Nancy Makin, Mary Frank, Val Hudspath, Ray and Diane Stone, Mary Berger. Members at large: Patti Johnston, Mike Parker, Jeff Sanford.

Secretary's Report – Cindy Foster

About 65% of last year's members have renewed, which is very good. We ended 2020 with 555 memberships, totaling 1106 members, 608 of whom were range members. Range members are not as prompt at renewing, but are reminded in April to renew before we order laminated ID Badges.

Treasurer's Report – Sam Hudspath

The year-end treasurer's report is included at the end of the minutes. Sam reports that our membership income is exceeding our expenses, due to minimal expenses during the pandemic, and lack of activities. We have about \$80,000 in the various accounts.

Sam will work with the Finance Committee to create a 2021 budget for presentation at the Annual Meeting.

Finance Committee – Steve Smith

There is nothing to report, but the committee is not forgotten, and Steve will get working on it in the next month.

Range Report – Diane Stone

Diane reports that the range has been busy, and has spent about \$9,800 on the 50-yard range, towards the \$23K anticipated total. The expenses to be spent will go to the shooting station enclosure, the wall at the far end, and more fill. The Town will reimburse us for 50% of the out of pocket expenses.

They also hope to use fill to enlarge the archery range to a 40 yard range.

The security system is still working well, and there has been plenty of range use. This was our busiest summer to date.

Activities Report – Patty Johnston

The spur of the moment hike at the end of December was successful with 5 hikers, others indicating interest.

Ski Trips – Mike Parker

We have a contract with Big Sky for January 22-29, 2022, and we are optimistic that the ski trips will be popular. We have a contract in process for a trip to Snowbird/Alta with Bonnie Farrar for next year, but there are details to be worked out. For that trip, skiers using the Ikon

pass will save significant funds. There are no plans in place, yet, for Snowmass/Aspen with Jon and Lee Goss. [1/27/21 – Ken is working on a contract for Snowmass/Aspen this week.]

This year, the Big Sky initial individual deposit of \$1000 to Great Events is due on June 15, which is earlier than in the past.

Mike suggested a request, in the February newsletter, for people's interests in the trips. Cindy will do that.

Ski Trip Deposits –

At our last meeting there was discussion about setting up a ski trip fund that might cover future losses. The only time we have lost money on a ski trip was last year when we had to cancel the Utah trip, losing the group deposit of \$1,500. Cindy's opinion is that we have plenty of money in the bank, and rather than complicate things with collecting additional funds for a rainy day fund, we should run trips as we have been, and take our chances on trip cancellations. Sam agreed that we have enough money and we do not need to build reserves.

Those present agreed that we can keep doing what we have been doing, and the monies collected can be used by the trip leaders for the benefit of those in their group. No vote was taken.

Officers for 2021 –

Mark will not be able to continue as president; Steve Smith will become president; Sam Hudspath will remain as treasurer; Cindy Foster will remain as secretary. [note: Terms ending 2021 include: Craig Lehigh, Jeannette Parker and Nancy Makin – Mark will contact them to discuss their interest in continuing.]
