# **CVOA Board/Member Meeting**

Saturday, June 19, 2021 At the Belgrade home of Val & Sam Hudspath

## MINUTES

**Present:** Officers: Steve Smith, Thom Johnston, Sam Hudspath, Cindy Foster; Directors: Mark Curtis, Mary Berger, Nancy Makin; Members at large: Elaine Smith, Al and Susan Fraser, Patti Johnston, Bob and Bonnie Farrar, Val Hudspath

Thanks are given to Sam and Val Hudspath for sharing their lovely yard and home on the shore of Great Pond in Belgrade, and for putting together a nice lunch from Subway.

2:10pm – the meeting was called to order by President Steve Smith, and he welcomed everyone and introduced the officers and directors who were voted into office at the March meeting.

#### Secretary's Report – Cindy Foster

625 memberships, 1000 members, 560 of whom are range members. These numbers include 138 officers from Dept. of Homeland Security agencies, Sheriff's Department and CVPD.

#### Treasurer's Report – Sam Hudspath, Treasurer

We are in a fiscally sound position with \$68,500 in the bank, \$6,500 held as deposits by Great Events & Escapes, \$450. in PayPal and \$9,000 in matching funds that will be coming from the Town of Carrabassett Valley 50-yard range grant. The June 10, 2021, Treasurer's report is included at the end of the minutes.

## Range Report – Diane Stone (Steve Smith)

Lack of ammunition will cut down on range use this year. Cleanup day at the range was very successful, with 32 volunteers and an extensive list of items completed. Stratton Lumber is donating and delivering the bark mulch we need to build the 50-yard range berms as well as a new berm that will be built between the trap field and the ranges, improving range safety. The bark mulch is also being used to fill in areas that will allow us to divert the road closer to the ranges, again increasing range safety.

Ray is looking into an RFID gate system, which would allow us to track range use, as well as provide better access for wheelchair-bound members such as we have. The RFID system might be about \$2500, with the costs of a new gate as yet to be determined. Cindy explained that we will not be using the entire \$15,000 50-yard grant from the Town of Carrabassett Valley, and the town has in the past allowed us to use unused matching funds for other range projects. This will be pursued.

#### **Old Business**

## Ski Trip updates

Snowbird/Alta has reservations from 21 people; we will promote the trip in future newsletters, and include the names of those who have already signed up. Snowmass/Aspen is nearly full with 33 reservations. Big Sky is full, and deposit payments are being collected.

#### New Business

**Membership Administrator** – Cindy needs to pass on the membership job, and will recruit someone from the Board and the general membership. The person must comfortable with Excel, and able to use Access or be willing to learn how to use Access. Patti Johnston will consider filling the position.

**Donation Request** – Adaptive Outdoor Education Center – AEOC is asking for a donation of \$500 to support their \$5,000 Fly Fishing program. A motion was made to award the donation of \$500; moved, seconded and approved unanimously. Application is at the end of the minutes.

**Donation Request** – Franklin Area Search and Rescue requested \$1600 to send two of their rope rescue members to attend training at Acadia. Discussion included information about FASR, which is a volunteer organization supporting search and rescue in Franklin County and surrounding areas. CVOA has given funds to FASR in the past - \$500 for new ropes, and \$500 for community education. A motion was made to award \$800 to cover half of their training costs with the expectation that they match the amount with other funds. Moved, seconded and passed unanimously. Application is at the end of the minutes.

**Homecoming Weekend** – Thom Johnston reported that he has secured a table for CVOA for Homecoming Weekend, which is October 9-10. The table will be located in the base lodge Guest Services lobby along with other local organizations. Thom will be looking for volunteers to help with the tables.

After beginning the meeting outside on a lovely blue-sky day, with thunderstorms imminent we moved inside just in time.

**Recognition of Neal Trask at the Range** – Neal has been involved with the range from the very beginning. Some might say that without Neal, the range wouldn't be what it is today. There has been talk of recognizing Neal in some way. Suggestions have been made for: naming the range for Neal; installing benches with his name; holding a trap shoot in his name; placing a large sign of recognition on a building; naming one of the buildings for Neal.

Those present at the meeting generally agree that the range should retain the CVOA name, not that of a single person. There was great support for a shooting event in Neal's honor. There was considerable support for a large sign recognizing Neal, placed at the clubhouse either inside or outside. The idea of placing benches in honor of volunteers such as Neal, and others in the future, was supported. Thom Johnston suggested that there should be some review of the range in light of recognizing volunteers, with a long-range plan for such recognition.

**2021 and 2022 Events** – it is never too early to start talking about events for the next year. For now, Cindy will send out an email to all members this week recruiting trip leaders for summer events.

The meeting was adjourned at 3:45.
